7.2 RIGHTS, OBLIGATIONS AND LIABITIES OF MEMBERS

- 7.2.1 Membership of the Association in any categories of membership does not and shall not give any member of any category a right to any of the moneys, property or assets of the Association but only confers upon such members the privilege of membership subject to such charges and reasonable restrictions as the committee may from time to time impose and subject to the by-laws in force for the time being.
- 7.2.2 A member whose application for membership has been accepted shall be bound by the constitution, rules and by-laws of the Association, and of any branch or section thereof, which are then in force, or which subsequently may be altered or amended and in force at any future time. No person shall be absolved from the effect and application of the constitution, rules and by-laws by reason for the fact that he/she may not have received a copy thereof.
- 7.2.3 The liability of members of any category is limited to the amount of unpaid subscription or other moneys owing by them to the Association and members shall not be liable for the debts and obligations of the Association in their personal capacity.

7.3 LIMITATION OF RIGHTS
